

How many solar projects does ACWA Power have in Saudi Arabia?

With the addition of these two projects, ACWA Power's solar portfolio in Saudi Arabia now exceeds 12GW of combined PV capacity. This includes the recent inclusion of three new projects with PIF subsidiary Badeel: the 2GW Ar Rass 2, 1.125GW Saad 2, and 1.4GW Al Kahfah solar plants.

Does ACWA Power have a sustainable future for Saudi Arabia?

This achievement illustrates our firm commitment to a sustainable future for Saudi Arabia and beyond." ACWA Power's portfolio of solar projects in Saudi Arabia now stands at 11, with over 12 GW of combined PV capacity, including the three new projects, bringing the group's total renewable capacity portfolio to 23.4 GW.

Will ACWA Power build a solar power plant in Baghdad?

The report did not provide further details of the project but Fadil said in 2024 that Acwa Power would build the plant as a joint venture with Iraq. Baghdad has awarded a number of solar power projects to foreign companies, including PowerChina and France's TotalEnergies.

What will ACWA Power do for Indonesia?

The projects will enable Indonesia to achieve its renewable energy target of 23% by 2025, under the country's National General Energy Plan. This marks ACWA Power's first foray into the Southeast Asian country, as well as the company's first floating solar PV projects in its portfolio.

How many homes will ACWA Power power in 2022?

In 2022, ACWA Power signed a power purchase agreement to develop the project in Al Qassim province, stating that once fully operational, the plant would generate enough energy to power around 132,000 homes in central Saudi Arabia.
