Alabama offers Solar Power Performance Payments, performance-based incentives (PBI), and production incentives through the Tennessee Valley Authority. The solar incentives come in the form of small cash

payments calculated based on the number of kilowatt-hours (kWh) or BTUs generated by your renewable

energy system, as measured by the meter.

Alabama Power offers no incentives for solar power, according to its website. The credit customers get for any

excess solar power they generate is at a lower-than-wholesale rate, Tait said.
