All electric utility companies regulated by the NJBPU (PSE&G,JCP&L,Atlantic City Electric, and Rockland Electric) and electric suppliers or providers must offer net metering to retail customers that generate electricity through renewable systems.

How much electricity does Atlantic City Electric sell?

Atlantic City Electric had \$1,434,115,300 in 2022in electricity sales. This includes \$992,392,000 from sales to residential energy users.

Does Atlantic City Electric lose energy?

Atlantic City Electric recently reported a loss of 5.44% of the electricity generation amount. This percentage of loss gives them a ranking of 9th best out of 60 suppliers who report energy loss in the state.
