

Why are rooftop solar companies going bankrupt?

Rooftop Solar Companies Keep Going Bankrupt. Lower Interest Rates Could Help It might take more than just "better" economic conditions to calm down the instability in the national solar installer market. Big rooftop solar companies have struggled in 2024 as high interest rates and policy changes put strains on their finances.

What has caused over 100 solar bankruptcies in 2024?

2024 has brought immense challenges, with higher interest rates, tighter financing, and adverse policy shifts in key states contributing to over 100 solar bankruptcies based on our industry data, a number unseen before in our almost 20 years in the solar sector.

Did SunPower go bankrupt?

SunPower wasn't alone in going bankrupt. Several other bankrupt solar companies made headlines in 2024. In January, ADT got out of the solar business. Titan Solar ceased operations in June. Lumio, another large national installer, declared bankruptcy in September.

How many solar installers went bankrupt in late 2023?

In late 2023 alone, more than 100 residential solar dealers and installers in the U.S. declared bankruptcy, according to Roth Capital Partners--six times the number in the previous three years combined.

Is Western solar going bankrupt?

Over the past couple of years, local installers such as Western Solar and many of our peers across Washington State have joyfully marked our 20-year anniversaries. Yet, in 2024 alone, several national solar companies have gone bankrupt, leaving frustrated customers in their wake.

Can a bankrupt solar company buy a solar panel?

Short answer: Yes. Why: If you financed your solar panels through your now-bankrupt solar company, another company will likely purchase the loan and you will still need to make the payments. Failing to make payments on the loan can have some serious consequences on your credit scores, result in fees and more.

If you have a solar lease, loan or PPA with a bankrupt company, your contract will likely be transferred to another entity. Bankrupt solar companies often sell these contracts as assets -- loans to lenders, and leases or PPAs to ...
