While other states have considered similar measures, none have implemented such mandates to date.

#### Are you exempt from California's Solar mandate?

Yes, there are situations in which you may be exempt from California's solar mandate and do not have to include solar power in your new build. Here are three of the most common exemptions. If your home is destroyed in a natural disaster like a fire or earthquake and you have to rebuild, there is a chance for an exemption to the mandate.
