

What is DCRC's partnership with solid power?

On 15 June 2021, DCRC announced its business combination agreement with Solid Power, Inc. ("Solid Power"), a Louisville, Colorado based producer of all solid-state batteries for electric vehicles, to which REL committed an additional \$20 million to the \$165 million PIPE that was raised.

How much did solid power make from the DCRC transaction?

Gross proceeds to Solid Power from the transaction amounted to \$542.9 million from a fully committed \$195 million PIPE and \$347.9 million of cash held in trust net of redemptions; only 0.6 per cent. of shares held by public stockholders of DCRC were redeemed.

What happened to solid power after DCRC's IPO?

Between DCRC's IPO and announcing the business combination with Solid Power, Solid Power closed on a \$130 million Series B investment raise led by BMW Group, Ford Motor Company, and Volta Energy Technologies.

When will solid power & DCRC complete a merger?

The boards of directors of both Solid Power and DCRC have approved the proposed transaction, which is expected to be completed in the fourth quarter of 2021, subject to, among other things, the approval by DCRC's stockholders and satisfaction or waiver of the other conditions stated in the definitive documentation.

What is solid power?

Solid Power's all solid-state platform technology allows for the production of unique cell designs expected to meet performance requirements for each automotive partner. In August 2021, REL purchased an interest in one of Samsung Ventures' battery technology focused venture capital portfolios (the "Samsung Portfolio") for \$30.0 million.
