Does Delmarva Power offer a green energy grant?

If you're lucky enough to be a Delmarva Power customer, you can qualify for a Green Energy Grantto go solar. The grant pays out \$700 per kilowatt (kW), up to a maximum amount of \$6,000 for your home solar installation! For example, on an average sized 6kW system, you can expect a rebate of \$3,600.

Does Delmarva offer a solar rebate?

Even if you're not a Delmarva customer, DEC and DEMEC offer their own similar solar rebate programs. Not too shabby! Delaware has also carved out 3.5% of it's ambitious state renewable energy standard to come from distributed solar generation by 2027, like panels on your rooftop. That's a strong move.

Can solar energy save you money in Delaware?

Delaware has made it easier to use solar energy through Delmarva Power, which advocates say can save you money. Gov. John Carney on Friday signed Senate Bill 2, which is expected to make it simpler for Delaware residents to use solar energy to power their homes through a new community-centered program scheduled to start next year.

How do I get a solar grant in Delaware?

Green Energy Program: Delmarva Power customers can apply for a solar grant through the Green Energy Program, administered by the Delaware Department of Natural Resources and Environmental Control, or DNREC. The Green Energy Program has provided grant funding to more than 4,300 Delaware renewable energy projects since 1999.

Does the Delaware Electric Cooperative offer a solar grant program?

The Delaware Electric Cooperative offers grantsto offset the installed cost of solar systems installed in their service territory. In order to be eligible for a grant the solar system must be installed by a participating contractor. Applications for their grant program can be submitted on their website.

What is the energize Delaware solar loan program?

Energize Delaware Residential Solar Loan Program: The Energize Delaware Solar Loan program, administered by the Delaware Sustainable Energy Utility, offers a low interest solar loandesigned to encourage the purchase of customer sited and owned solar systems.

Under the program, incentives are available for the installation of qualifying photovoltaic (PV), solar water heating, wind turbine, and geothermal heat pump systems. The ...
