

What solar incentives are available in Virginia?

Residents in Virginia can benefit from several solar incentives, including the 30% federal solar investment tax credit, Virginia's Solar Renewable Energy Credits program, property tax exemption and net metering.

Can I get compensation for solar panels generated by Dominion Energy & Appalachian Power?

The chapters authorize a multi-family shared solar program in the service territories of Dominion Energy Virginia and Old Dominion Power.
