## Electric car charging station rebate

How many EV charging stations can I get a rebate?

Rebates are limited to one one EV charging stationrebate per household. For more information, see the KUA website. Carroll EMC Members who lease or purchase a new BEV could qualify for a monthly credit of \$30 on their power bill to cover the cost of charging the EV for one year.

#### How do EV charger incentives work?

Most electric vehicle and EV charger incentives come in the form of tax credits or rebates. Rebates are a sum of money returned to a customer after a transaction. Many utility companies and state governments offer EV rebates and EV charger rebates. Tax credits, like the federal EV tax credit, reduce the amount of tax owed.

#### Does Entergy offer EV charging rebates?

Entergy customers are eligible for a \$250 rebate for a Level 2 EV charger. Mississippi offers a \$250 rebate for Level 2 EV chargers. Missouri customers of Evergy and Kirkwood Electric are eligible for EV charger incentives. Missouri EV owners are subject to an additional EV fee. EVs are subject to a \$105 annual fee for a special fuel decal.

#### Does bed offer a rebate on EV charging stations?

BED also offers a rebate of up to \$900for the purchase and installation of a qualifying Wifi enabled EV charging stations for customers that have enrolled in BED's Residential EV Rate. Eligible applicants must have purchased an EV charging station within 60 days of the acquisition of the EV.

#### What EV charger rebates are available in Washington State?

Dominion Energy customers are eligible for a \$125 rebate for the purchase of a Level 2 EV charger. Danville Utilities customers are eligible for a \$200 rebate for the purchase and installation of a Level 2 EV charger. Washington utility companies offer EV rebates and EV charger rebates.

#### Are EV chargers eligible for a rebate?

Residential electric customers are eligible for a \$600rebate when they install a qualifying "Wi-Fi enabled" or "Internet Connected" EV charger at their home. Residential customers are eligible for a \$200 rebate when they install a standard (Non Wi-Fi/Non Internet Connected) EV charger.
