Do condominiums need EV charging stations in Florida?

Florida law requires condominium associations to accommodate owner's requests for EV charging stations to accommodate the need for new facilities associated with electric vehicles. While gasoline powered vehicles are still dominant on Florida's roads, the ever-growing presence of electric vehicles cannot be ignored.

Can You charge an electric vehicle in a condominium in Florida?

In Florida, condominium associations are required by law to accommodate an owner's request to enable electric vehicle charging. However, the cost for this accommodation can be charged to the owner. Electric vehicles can be charged in a condominium in Florida at three levels, based on the rate at which a vehicle can recharge. Higher levels indicate faster charging levels.

Can a condominium owner install an electric vehicle charging station?

If the parking space is a limited common element, a condominium owner may install an electric vehicle charging station, subject to the requirements of the new legislation. These requirements include: 1) The installation cannot cause irreparable damage to the condominium property.

Do condominiums need Level 2 EV charging stations?

There are two different ways to address the need for Level 2 EV charging stations in condominiums: Install stations dedicated to assigned or deeded parking spots for specific owners. This approach is primarily oriented towards condominiums with access-controlled garages.

Who is required to install an electric vehicle charging station?

An association may require the unit ownerto engage the services of a licensed and registered electrical contractor or an engineer that is familiar with the installation and requirements of an electric vehicle charging station.

Can a unit owner install a charging station?

An association may require a unit owner to comply with all safety requirements, applicable building codes, or recognized safety standards before installing an electric vehicle charging station, for the protection of the association property and its members.
