

Who owns Smyrna battery plant?

The 400-employee lithium-ion battery plant at Smyrna is part of AESC. Smyrna battery plant employees -- including the management team led by Jeff Deaton -- are expected to become employees of the new battery venture being set up by Nissan and Envision. Nissan spokesman Brian Brockman on Friday said the deal is scheduled to close before March 29.

Where is envision AESC building a battery plant?

The battery factory in Spain joins Envision AESC's growing list of battery projects: in China, the company is building a battery plant with an annual capacity of 20 GWh. A joint battery factory with Nissan in Japan was announced in August 2021.

Who owns Nissan's Smyrna battery plant?

Envision aims to harness the global electric grid to an innovative fleet of new battery-powered vehicles. A fast-growing pioneer in China's wind energy industry is taking control of Nissan's Smyrna battery plant. Shanghai-based Envision Group will acquire a 75 percent stake in Nissan's Automotive Energy Supply Corp.

Who is envision & how will it help Nissan Smyrna?

Envision is set to become the crucial supplier of battery technology for the Leaf electric car assembled at Nissan Smyrna. Taking control of AESC also will aid Envision's role in trying to harness the global electric grid to an innovative fleet of new battery-powered vehicles.

How big is Nissan's Smyrna battery plant?

Nissan opened the 475,000-square-foot Smyrna battery plant in 2012 and last year began to add about 25,000 square feet of floor space. That expanded area is nearly ready for use, Brockman said. Nissan recently scrapped the proposed \$1 billion sale of AESC to the Chinese investment firm GSR, saying the firm was unable to finance the purchase.

Will envision take control of AESC?

Taking control of AESC also will aid Envision's role in trying to harness the global electric grid to an innovative fleet of new battery-powered vehicles. In March, the company displayed an electric concept car named the GFG Sibylla at the Geneva Auto Show.
