Does Eversource offer other solar incentives?

Eversource does not offer other solar incentives directly to customers. However, there are other incentives available, such as the federal tax credit for solar and some state incentives. Interconnection is the process of physically connecting your solar panels to Eversource's electric power system.

Does Eversource store excess solar energy?

Eversource banks excess solar energyyou send to the grid for customers in CT. The extra kilowatt-hour (kWh) credits are applied for you to use in the following month(s).

How much does Eversource cost per kilowatt hour?

That's more than the 8.99 cents per kilowatt hour those customers are currently paying, but less than the 14.71 cents per kilowatt hour Eversource customers paid during the first six months of 2024. The rate Eversource presented to utility regulators is 24 percent lower than last winter and the lowest winter supply rate since 2021.

#### How does Eversource work?

Eversource is required by state law to allow homeowners to connect solar panels to their homes and to the grid. The company tracks the solar energy you produce and the grid power you consume, then gives you credit if that production exceeds consumption through a process called net metering. Eversource is involved in the process of enabling homeowners to use solar energy and manage their energy consumption.

#### Does Eversource offer solar rebates?

Eversource does not offer any solar rebates directly. However, customers of Eversource can take advantage of the federal solar tax credit, which is equal to 30% of the cost of installing a solar panel system. You can get that money back on your taxes the year after installation.

What is the process of connecting solar panels to Eversource's grid?

Interconnection is the process of physically connecting your solar panels (or other renewable energy source) to Eversource's electric power system. Eversource does not offer other solar incentives directly to customers. However, there is a federal tax credit for solar, as well as some state incentives.
