Basically, for most systems, count on \$1,000 off next year's state income tax bill, on top of the big savings from the Feds.

What program did Massachusetts introduce in 2018 for solar owners?

Massachusetts introduced its SMART program in 2018as a way to compensate solar owners for the electricity their systems generate after its solar renewable energy certificates (SREC) program reached capacity. The only catch is that your system has to be installed on your primary residence.
