Does Ohio offer a solar tax credit?

Ohio residents can take advantage of the 30% Federal Solar Tax Credit (ITC). This credit is available for home solar systems purchased and installed by the end of 2032, as per the Inflation Reduction Act. If you purchase \$20,000 worth of solar panels, you can get a credit for \$6,000 on your next tax return.

What incentives are available for solar conversion in Ohio?

The federal solar creditis one of the most appealing financial incentives for solar conversion available in Ohio. It's offered by the federal government, and all new solar customers are automatically eligible. Basically, the credit is for 30% of your system value, which gets applied to your tax burden for the year you install your solar equipment.

How much does a 5 kW solar system cost in Ohio?

The Residential Clean Energy Credit, formerly known as the federal investment tax credit (ITC), can reduce your solar panel system's cost by 30%. Your entire system qualifies for this incentive, including equipment, labor, permitting, and sales tax. The average cost for a 5 kW solar panel system is around \$12,968 in Ohio.

How do I get solar energy credits in Ohio?

Fill out the form using the documentation you get from your installer. Ohio mandates that 8.5% of the state's electricity be generated by renewables by 2026. To help achieve that goal, utility companies will buy electricity produced by customers' solar panels in the form of solar renewable energy credits (SRECs).
