The subject line of the email should be: "HOME Solar RFP Response." It is required that attachments with file sizes exceeding 8MB be compressed (i.e., zipped) and/or divided into multiple PDFs and e-mails with individual files labeled Volume I, Volume II, etc. to ensure message delivery.
