San Diego Gas & Electric (SDG&E) needs to accurately track the number of PEV charging stations installed to properly plan for local increases in electricity demand due to vehicle charging.

Does SDG&E offer a rebate?

SDG&E provides a rebate of up to 100% of the cost of the charging station. See Charger Rebates section for more details. Below are the most common infrastructure terms used throughout the Power Your Drive for Apartments and Condos Program.

Are the power your drive charging stations included in the program?

The approved Power Your Drive charging stations are included in the program at no additional cost. No other chargers can be substituted. The charging vendors may offer additional services, like managed parking, fleet EV management, or load management; however any additional cost for these services is not included.

What could happen if SDG&E doesn't track PEV charging stations?

If San Diego Gas & Electric (SDG&E) doesn't accurately track the number of PEV charging stations installed, the combined effect of several chargers in the same area could result in overloads on utility secondary wires and transformers.
