Who can try an impeachment?

Who decides if a president is impeached?

When the President of the United States is tried, the Chief Justice shall preside: And no Person shall be convicted without the Concurrence of two thirds of the Members present. Rather than allowing a coordinate branch to play a role in the impeachment process, the Framers decided that Congressalone would determine who is subject to impeachment.

What are the rules for impeachment trials?

That provision establishes certain basic rules for impeachment trials--the Senate shall be on "Oath or Affirmation;" the Chief Justice presides since the President is the defendant; conviction requires a two-thirds vote and can impose no punishment except removal from office and disqualification from future office--but leaves much to the imagination.

What does Article 3 of the constitution say about impeachment?

Article III of the U.S. Constitution does not mention impeachment expressly,but Section 2,Clause 3 provides that trials, 'except in Cases of Impeachment, shall be by jury.'

Now that the House of Representatives has impeached President Donald J. Trump for alleged high crimes and misdemeanors, proceedings will shift to the Senate, which has the "sole Power to try all Impeachments" under
