

What types of funding programs are available for solar energy projects?

Funding programs encompass at least one research area: photovoltaics (PV), concentrating solar-thermal power (CSP), systems integration (SI), soft costs (SC), manufacturing and competitiveness (M&C), and solar workforce development (WF). What is a 'Solar for All' grant?

A 'Solar for All' grant is funding provided to enable low-income and disadvantaged communities to deploy and benefit from residential distributed solar.

Who can compete for Solar for All grant funding?

Only states, territories, municipalities, Tribal governments, and eligible nonprofit recipients can compete for funding under the Solar for All grant competition. No, only these entities can apply.

Can nonprofits apply for a Solar for All grant?

No, only states, territories, municipalities, Tribal governments, and eligible nonprofit recipients can compete for funding under the Solar for All grant competition.

Can a grant be used to fund a community solar project?

Grantees may use program funds to provide financial assistance to residential-serving community solar projects.

Does EPA fund solar for all projects?

EPA will not fund individual projects through Solar for All. Instead, it supports programs that provide access to solar energy for low-income households, often through financial support and other incentives.
