The federal solar investment tax credit (ITC) is the most significant solar incentive in Arizona. You may also take advantage of tax breaks, rebate programs or incentives through Mohave Electric Cooperative or the City of Scottsdale.

Arizona's state tax credit equals 25% of solar power system costs, up to \$1,000. Most solar installations will earn the maximum \$1,000 incentive. There are no statewide Arizona solar rebates, but it does have the AZ solar tax credit. Arizona's tax credit is equal to 25% of system costs up to \$1,000, and it reduces your state income tax liability.
