

## Solar power purchase agreement rates in gujarat

Can DISCOM buy power from solar project in Gujarat?

AND, WHEREAS in "Gujarat Renewable Energy Policy - 2023", stipulated that DISCOM may purchase power from Solar project up to 4 MW project capacity to fulfil their RPO for which applicable tariff shall be as per the mechanism stipulated in the said policy.

Can solar power projects be sold to distribution licensees of Gujarat?

The Solar Power Projects to be installed and commissioned under PPAs signed during the new control period will be eligible to sell power to distribution licensees of Gujarat at the tariff approved by the Commission under this Tariff framework and consumption of solar energy for Captive Use /third party sale.

Who approves solar projects in Gujarat?

Approval of the Chief Electrical Inspectorate Gujarat for projects located in Gujarat and of Central Electricity Authority for projects located outside Gujarat for charging & synchronization of the transmission line and the solar project installed at the Project Site.

What happens if Gerc determines generic tariff for solar project?

Further, in case generic tariff is determined by GERC for solar project and such tariff is lower than tariff as stated in above para, lower tariff will be applicable for purchase of solar power from such project and the same shall be fixed for entire term of PPA. Regulations, 2024 on 20.02.2024.

How much bank guarantee is required for solar power project?

The Solar Power Project Developer shall be required to provide Bank Guarantee @Rs. 10 lakhs per MW to GETCO based on allotment of transmission capacity and in case the Developer fails to commission the capacity within the time-period mentioned hereunder, GETCO shall encash the Bank Guarantee. 02. 03.
