How do I Register my solar system?

Determine if your system is grid-connected or off-grid and ensure compliance with safety standards. Apply to your municipality or Eskom with all required documentation. Await review and inspection for final approval. Don't risk these consequences - register your solar system before the deadline!

What if I don't register my solar system?

A deadline has been set by Eskom for solar system registration. Failure to do so will result in a fine. The power utility issued a statement on 11 February 2025, stating that solar users have until March 2026 to register their grid-tied systems. According to Eskom, all grid-tied systems that are unregistered are now deemed illegal.

How do I register a solar system with Eskom?

The public has until March 2026 to register their solar systems. To register for a solar system with Eskom, you must apply for a small-scale embedded generator (SSEG) by completing a form that can be accessed through the Eskom website. These are the steps you should follow:
