

How much solar subsidy can you get in Tamil Nadu?

In Tamil Nadu, you can avail of state and central solar subsidies. Let's see how much you can get from the Tamil Nadu solar subsidy: TN Govt subsidy for solar panels is also known as Chief Minister's Solar Rooftop Capital Incentive Scheme. This scheme offers a subsidy of Rs. 20,000 per kilowatt for on-grid residential solar.

What is rooftop solar subsidy scheme in Tamil Nadu?

The Tamil Nadu Government has inaugurated a Rooftop Solar Subsidy Scheme in partnership with the Government of India (Ministry of New and Renewable Energy--MNRE). This scheme has made solar power more accessible to Tamil Nadu consumers through the services of handpicked dealers.

When will Tamil Nadu solar subsidy be credited to my bank account?

The Tamil Nadu solar subsidy will be credited to your bank account within 30 days after approval. The Union government has set a goal to install 25 lakh solar systems in households in Tamil Nadu under the PM Surya Ghar Scheme from April 1, 2024, to March 31, 2025.

What is the solar subsidy scheme in India?

The Chief Minister's Solar Rooftop Capital Incentive Scheme provides a capital subsidy of INR 20,000 per kilowatt for grid-connected domestic solar PV systems in addition to the existing 30% subsidy scheme of the Ministry of New and Renewable Energy (MNRE) of the Government of India.
