Solar power tasmania government rebate

What is a solar rebate in Tasmania?

It's a solar rebate that works by rewarding those who install solar panels in Tasmania with renewable energy certificates that your solar installer can use to discount installation and system costs. Tasmania is a Zone 4 qualifier, meaning it receives fewer STCs than those living in Zones 1,2 and 3, where solar radiation levels are higher.

Does Tas have state-based rebates?

As mentioned above, TAS does not have state-based rebates. So, all eligible homeowners and businesses receive the Federal Government STCs. STCs are tradable certificates awarded to your solar system as part of a sales discount. Every solar system is awarded a certain number of STCs depending on its size. You can see this in the table above.

Are there solar rebates in Texas?

Although there are no state government rebates, federal rebates apply just like the rest of the country. Eligible homeowners and businesses receive subsidies for solar panels, battery systems, and solar hot water claimed through their solar installer. Does Tasmania have solar panels?

Tasmania seems unlikely to have an abundance of solar panels,but according to the Clean Energy Regulator,59,000solar panel systems are powering homes and heaters around the state. For those Tasmanian households considering installing solar panels,there may be concerns about price,rebates and solar feed-in tariffs.

What is a solar rebate?

The solar rebate is an amount of money you get refunded for having solar panels installed. As a reward for installing solar panels with renewable energy certificates, your solar installer can use the solar rebate to discount installation and system costs. Basically, it makes solar panels cheaper to buy and install.

Am I eligible for a solar or battery rebate?

You may be eligible for a solar or battery rebatedepending on your location. Some states and territories allow you to apply for a rebate on top of an interest-free loan. These can complement one another and further reduce the cost of your system. You will still be able to collect small-scale technology certificates (STCs) under the Small-scale Renewable Energy Scheme (SRES).
