#### How do you weigh a container under the SOLAS amendments?

Under the SOLAS amendments, there are two permissible methods for weighing: Method 1, which requires weighing the container after it has been packed, or Method 2,2 which requires weighing all the cargo and contents of the container and adding those weights to the container's tare weight as indicated on the door end of the container. 3.

#### What is the SOLAS container weight Verification Regulation?

Previous amendments were made in May 2011. In 2015, another later amendment is the SOLAS Container Weight Verification Regulation VI/2. This regulation, implemented by the IMO Maritime Safety Committee (MSC) requires that the full weight of loaded containers must be obtained prior to being onboarded on an ocean vessel.

#### What is SOLAS Convention in shipping?

SOLAS Convention. The International Convention for the Safety of Life at Sea (SOLAS) is an international maritime treaty which sets minimum safety standards in the construction, equipment and operation of merchant ships. The convention requires signatory flag states to ensure that ships flagged by them comply with at least these standards.

#### Do SOLAS amendments require a carrier to verify a shipper's weight?

Nordo the SOLAS amendments require a carrier to verify that a shipper providing a verified weight according to Method 2 has used a method which has been certified and approved by the competent authority of the jurisdiction in which the packing and sealing of the container was completed.

#### Does a packed container have a verified weight?

The International Maritime Organization (IMO) has amended the Safety of Life at Sea Convention (SOLAS) to require, as a condition for loading a packed container onto a ship for export, that the container has a verified weight. The shipper is responsible for the verification of the packed container's weight.

#### What are the SOLAS amendments?

The SOLAS amendments provide that there are two methods shippers may use to determine the container weight once the container packing process has taken place. This requirement will apply globally.
