

Where do bills for raising revenue originate from?

All Bills for raising Revenue shall originate in the House of Representatives. The Senate may propose or concur with Amendments as on other Bills. This clause is a prerogative of the House, allowing it to initiate such bills.

Who initiates a revenue bill?

Revenue bills for the United States federal government can only be initiated by the House of Representatives. The Senate can propose amendments to existing revenue bills, but the House has ultimate authority for initiating a new form of revenue or major adjustments to an existing one.

How does the Senate create revenue bills?

The Senate creates its own revenue bills through a process called "gut and replace". Relying on the Rulemaking Clause, the Senate originates 'bills to raise revenue'.

Can the Senate propose a new revenue bill?

The Senate can propose amendments to existing revenue bills, but the House has ultimate authority for initiating a new form of revenue or major adjustments to an existing one. The unique ability of the House to propose revenue bills is sometimes referred to as the "Power of the Purse."

Where does the revenue bill come from?

The foundation for the concept of the revenue bill comes from the United States Constitution, which states that "All Bills for raising Revenue shall originate in the House of Representatives." This clause, known as the "Origination Clause," has been interpreted to include only those bills that are explicitly meant to create revenue.
