#### Will Complete Solaria acquire SunPower's assets?

As part of the bankruptcy, Complete Solaria will buy SunPower's Blue Raven Solar and New Homes subsidiaries, as well as other parts of the SunPower dealer network. The company is now filing for Chapter 11 bankruptcy and selling most of its assets in an organization-wide wind down.
