What is a Sungrow warranty registration form?

The "Registration Form" is the Photovoltaic Inverter Warranty Registration Formas set forth in SUNGROW's website. The Registration Form must be completed and returned to SUNGROW. 1.7. "Service" means Actions in Item 2.1 in response to a claim. 1.8. "Site" means the location of End-user's Product that is covered under this Warranty. 1.9.

Failure to provide full information may delay the warranty process. 1. What is the warranty period for Sungrow inverters?
