Construction will take place in two phases with an initial annual capacity of 30 GWh and a further 20 GWh at a later date.

Where are sunwoda batteries made?

The company's other battery factories, with annual capacities of 30 GWh and 20 GWh, respectively, are reportedly being built in Zhuhai (Guangdong province) and Shifang (Sichuan province). As indicated by CN EV Post, Sunwoda has announced 14 investments since March 2021, totalling 110 billion yuan (15.7 billion euros).
