Who has the power of impeachment?

Article I,Section 2,Clause 5: The House of Representatives shall chuse their Speaker and other Officers; and shall have the sole Power of Impeachment. Consequently, the historical practices of the House with regard to impeachment flesh out the meaning of the Constitution's grant of the impeachment power to that body.

What does the constitution say about impeachment?

The Constitution outlines the process of impeachment in Article I,Section 2,which states,"The House of Representatives shall choose their Speaker and other Officers; and shall have the sole Power of Impeachment. Impeachment relates to the removal of a Government official due to crimes committed while that individual was in office.

Which house of Congress tries impeachments?

The Senate has the sole power to try those impeachments. It is important to note that impeachment is a power that is granted to both Houses of Congress. The House of Representatives has the "sole Power" to impeach, while the Senate has the sole power to try those impeachments.

Which branch of the US government has the sole power of impeachment?

The House of Representatives shall chuse their Speaker and other Officers; and shall have the sole Power of Impeachment. Vice President, and other federal officers--including judges--on account of treason, bribery, or other high crimes and misdemeanors.

Who decides if a person is impeached?

In exercising the power of impeachment, the House determines whether to impeach, and if impeachment occurs, the Senate decides whether to convict the person and remove him from office.

What does Article 3 of the constitution say about impeachment?

Article III of the Constitution does not mention impeachment expressly, but Section 1 establishes that federal judges shall hold their seats during good behavior. Additionally, Article III, Section 2, Clause 3 provides that trials, except in Cases of Impeachment, shall be by jury.
