How much money does Titan solar power have in bankruptcy?

Titan Solar Power, which was founded locally in 2013, filed for Chapter 7 bankruptcy protection June 20. The company estimated it has between \$1 million and \$10 millionin assets against \$1 million and \$10 million in liabilities, according to its petition with the U.S Bankruptcy Court for the District of Arizona.

#### What if a solar contractor goes bankrupt?

#### What happened to Titan solar?

Titan is not the only solar installer to close up shop lately. The company, which could not be reached for comment for this story--its website has shut down--is one of 16 major solar outfits that have filed for bankruptcyin 2023 and 2024, according to Solar Insure, which offers warranties and monitoring for homeowners who have solar.

### Why did Titan go bankrupt?

That day, Titan's employees received an email that said company leadership had tried and failed to find a buyer for the companyand bring in new sources of capital and that the company would close effective immediately. A week later, Titan filed for Chapter 7 bankruptcy liquidation in Arizona.

#### Does Titan solar have assets available to pay creditors?

A statement provided on the Court's web page says,"In most of the cases filed, it appears that there are no assets available to pay creditors." Titan's closure is the latest in a string of high-profile solar company failures, including Pink Energy (formerly Powerhome Solar), ADT Solar, and others.

### Is Titan solar closing its doors?

Titan Solar, which installed thousands of systems across the U.S., informed its employees June 13 that it was "closing its doors," having failed to secure a buyer for the company, according to an email obtained by TIME. In the email, Titan said that it had helped over 100,000 households go solar.
