Titan Solar Power, founded in March 2013 in Mesa, Arizona, has grown to become one of the fastest growing solar installers in the southwestern United States. It plans to expand across the South and Midwest regions of the country.

Is Solar Titan a good company?

Some customers have reported positive experiences with Solar Titan, such as a quick installation process and good sales team. However, others have had issues, including a failed State Electrical inspection that was slow to be resolved. There have been complaints about poor customer communication and customer service. It appears that the overall experience with Solar Titan can vary.

Is Titan a policing company in Nevada?

The company came under scrutiny after numerous customers filed complaints with the Nevada State Contractors Board, the agency in charge of policing business license holders in the state. Titan has been on probation with the board since May 2023.
