These dealers sold solar systems on behalf of Titan, which then managed the installations. The financial arrangement involved a pricing model, where Titan charged a fee for the completion of the project, and dealers kept the remaining amount as their commission.

#### How did Titan solar power start?

Titan Solar Power had established itself through a vast Solar Dealer program,partnering with many solar sales organizations. These dealers sold solar systems on behalf of Titan,which then managed the installations.
