

What happened to Titan solar power?

Titan Solar Power, a large US residential solar installer, unexpectedly ceased operations on June 13, 2024. The Chandler-based solar company, founded in 2013, filed for Chapter 7 bankruptcy protection on June 20. The company reported having between 5,001 to 10,000 creditors. Kyle Beddome is listed as the company's business owner.

Was a new buyer sent to Titan solar power employees?

This new buyer was meant to bring "new sales channels to the company and take us in a new direction" according to an email shared on social platform Reddit that is alleged to have been sent to employees of Titan Solar Power (see below).
