Will Washington State Fund EV charging infrastructure?

In Aug 2023, the Washington State Department of Commerce announced a grant program to provide \$64 millionin funding for EV charging infrastructure. Learn more.

How much will Washington State spend on EV charging?

In the plan, Washington State notes that it expects to invest about \$71 millionfrom this program over five years, along with a 20 percent non-federal match of \$17.75 million. The funds will be used to expand the state's public charging network and create a more equitable experience for EV drivers.

Where can EV charging stations be installed in Washington State?

Eligible sites for EV charging station installation included multifamily housing, public charging, fleet depots, and workplaces. Washington State is a model for the nation in terms of its comprehensive and forward-thinking approach to EV charging infrastructure.

How many EV chargers are installed in Washington State?

The investment is through the Washington State Electric Vehicle Charging Program, with additional support from the Climate Commitment Act. The awards will result in the installation of 4,710Level 2 EV chargers with 5,362 individual charging plugs, and 271 direct current fast chargers with 420 plugs.

How did Washington State get EV funding?

Funding was allocated to applicants based on a competitive scoring systemthat prioritized installations in areas with high levels of pollution and few existing chargers, among other criteria. Washington state has been a leader in the U.S. in EV adoption, showing steady growth over time.

The bill encourages electric-car ownership for middle-income households by eliminating sales tax for new plug-in cars worth \$45,000 or less, and used plug-in cars worth \$30,000 or less.

The program offers \$64 million in awards for organizations installing EV chargers at certain sites, with a focus on multifamily housing, publicly available charging and tribal locations.
