Does Washington have a solar tax exemption?

The exemption is available through 2029and can exempt sales taxes for the purchase of machinery, equipment, and installation of solar energy systems. For more information, visit the Washington Department of Revenue's website. The federal government first enacted a solar investment tax credit (ITC) in 2006.

Does Washington have a solar rebate program?

Washington's one other big solar rebate is known as the Renewable Energy System Incentive Program. While RESIP is still an active program, it reached full capacity in 2021 and is no longer taking on new customers. The Washington State Legislature would need to authorize additional funding for the program to open up again.

Are solar panels tax deductible in Washington State?

In Washington State, solar panels are not tax deductible. However, there are other benefits to installing solar panels, such as a sales tax exemption for qualifying solar equipment (ESS Senate Bill 5116) for systems smaller than 100 kilowatts from July 2019 through December 2029.

What is the solar incentive program?

The program provides incentive payments for renewable energy systemsowned by residential and commercial utility customers, as well as community solar installations. As of June 2021, the program is fully subscribed, and is no longer taking new applicants.

How much does community solar cost in Washington State?

Washington state residents can subscribe to community solar through their electricity utility. Puget Sound Energy allows customers to sign up for \$20 per month, but in return, they get bill credits for the solar energy generated by their share. Community solar doesn't always save you money.
