The House has several powers assigned exclusively to it, including the power to initiate revenue bills, impeach federal officials, and elect the President in the case of an electoral college tie. The Senate is composed of 100 Senators, 2 for each state. What sole power is given to the House of Representatives?

These include: drafting appropriation bills, filing a case of impeachment against the President and electing a President if no candidate receives a majority of the electoral vote. What powers does Congress have?

Congress, as one of the three coequal branches of government, is ascribed significant powers by the Constitution. All legislative powerin the government is vested in Congress, meaning that it is the only part of the government that can make new laws or change existing laws.

What is one power unique to the House of Representatives?

One power unique to the House of Representatives is that they can elect the next president if no candidates receive majority vote. The House also starts all revenue (money) bills and has the power to impeach civil officers. What powers does the Senate have?

The Senate maintains several powers to itself: It ratifies treaties by a two-thirds supermajority vote and confirms the appointments of the President by a majority vote.
